PRESIDENT'S REPORT 2016 - 2017



The last twelve months has been an exciting time in Four Wheel Drive Victoria. Much has happened and many decisions have been made. I'm now confident that the Association is heading in a very positive direction and has a secure future. I must say a big thank you to all of our Club Members who had confidence in me and I hope I've lived up to expectations.

Over the past year there have been several changes on the Board so I must thank Michael Coldham who resigned earlier this year. Michael was, and still is a great contributor to the Association. David Crainean who has previously been a Board member replaced Michael. Chris Whiteside stood down from his position as Secretary and David chose to take on that role. So thanks Michael, Chris and David.

I know in other parts of this report you'll see summaries of our activities over the past year so I'll summarise them from my point of view.

We've been very active with the Ministerial Advisory Committee having met three times since the last AGM. The committee have been working on the Victorian 4WD Strategy which is a four year strategy that includes FWDV, DELWP and Parks Victoria. As a tripartite document, I'm impressed at the way the three organisations have cooperated to end up with a document we can all be proud of. The latest update is that the document is in the Minister's office waiting for final approvals and a launch. Of course the strategies need to be implemented and that starts with our Operational Plan. This plan includes the KPI's we need to meet to ensure our funding. I've been presenting these plans at each of our general meetings in Warragul, then at Bulleen and finally at Tarrawingee.

The plans have been well accepted and I think that's because there's now a high level of transparency with what we are trying to achieve and it makes sense. It's about bringing 4WD tourism to the forefront in Victoria. There is a lot of work to be done and our plan is to have regional meetings to involve clubs in its implementation when signed off.

We had a plan to conduct our general meetings in the regions this year and we'll continue that next year. It's been a great success with good numbers attending each meeting. There are some proposed changes being presented at the AGM to meeting structures to clarify their purpose. These general meetings will become a member update rather than a general meeting where technically we need a quorum of members. This can be difficult to achieve in the regions so by removing this need, the meetings will now not have this requirement but will still deliver the same updates as before. I'm looking forward to having meetings in a number of new venues next year.

One of the main actions I initiated following last year's AGM was a review of our rules. We hadn't reviewed them since the legislation required us to in 2013 and

there were some anomalies. I asked a sub-committee of the Board to review them which they did. The many changes we recommended were discussed at Board meetings and the final version was agreed on. Clarity to our objective came when we appointed David Crainean as our Secretary. David has had many roles as Company Secretary so understands compliance requirements. David was also involved in the early version of our rules back in 2013. When he reviewed our changes, he made comment that there were already those provisions in the rules. David and I met and what appeared to have happened was we were using as a base the wrong set of rules. Apparently, there had been a review some time ago but this didn't eventuate in any decision to take them to members. When we examined the correct rules from 2013, they required only a few changes, which are being presented at the AGM. A simpler approach but one that will achieve the outcomes we need.

The RTO has also been through some significant changes. We appointed Matt Lilley as a part-time RTO Manager supported by Mentor – a business that assists RTO's in their work. Together the RTO is now very close to being 100% compliant. We have been running two separate RTO meetings each month and this has now come back to one only at which we get a lot of business done. As a result of and more especially due to the hard work of Wayne and the staff in the office, our training courses are increasing in volume, especially the Corporate Courses, so we need more trainers to deliver this extra workload.

Financially you will see we made a good surplus last year. This is our journey to self-sufficiency, which is one of our strategies. We have kept fees the same and over the coming year we'll be looking for more benefits for our members. The Member Benefit scheme introduced by the National Council has ceased and we will be looking to replace this with something far more tangible.

We still have a lot to do and systems and processes to develop, but the journey is well under way. A big thanks to the Board but especially to Wayne for his day-to-day management of the Association and all the staff in the office who collectively with us as members make this Association so great.

CEO'S REPORT 2016 - 2017



The last financial year has seen FWDV become more self-reliant in terms of its financial standing and managerial structure culminating in a very sound end of year position which can be seen in our auditor's statement later in this report. We have been very cognisant of our continued support from the government and its land managers in terms of our strategic planning initiatives, building a platform that we can launch ourselves off when required, in the most productive and professional way. Once again, you the members have allowed strong conversation to occur based on the enormous contributions recorded against the activities performed across the tracks and campgrounds over the year. Without this vital data and statistics, this would certainly not be possible.

Our DELWP/PV funding report at June 30th, 2017, showed a total of 12,284 hours worked against an expected total of 2,500 hours. There were 1320 member involvements showing 3715 travel hours with a combined distance travelled of 248,995.9 kms and a local expenditure of \$30,251 cents. The total days spent in the bush were 214 which is a wonderful record highlighting the valuable effort achieved by our membership making a very impressive document to present to the Minister and our land manager partners. Geoff Kenafacke is the man responsible for collecting and collating this most valuable information, I can't thank him enough for his undying service in this regard.

The Ministerially appointed 4WD Advisory Committee has presented the final draft of the strategic plan to the Minister and we are looking forward to the announcement being made of its acceptance in the very near future. This will then enable us to publicise the details and commence working on the short-term actions required from it.

We have been in our new office for a full year now and although it can be a little noisy at times when trying to hold telephone conversations, it works very well for us in terms of getting things done in a timely matter. Conversations are still taking place with the land managers on securing a property where we can combine our business operations with a training centre.

During the past year we have been actively involved with the Mt Stirling Stakeholder's Group developing a Strategic Management Plan for both Mt Buller and Mt Stirling, made submissions to the Gunaikurnai management plans as well as the River Red Gum management plan along with being involved in the Victorian Environmental Assessment Council (VEAC) Central West Investigation. All of these to ensure our continued ability to be heard with regards to retaining our recreational use of the landscape whilst demonstrating our conscious environmental concerns.

Our Registered Training Organisation (RTO), is moving along steadily with courses being conducted on a regular basis with more corporate work being quoted and fulfilled as time and manpower allows us. The RTO has been very active this past year in many aspects particularly in the upgrading of qualifications of our instructors by means of upskilling and recognition of prior learning (RPL) along with the running of more courses to assist this process. Applications from 7 clubs introducing 9 new trainee instructors over the 16/17 year has been very promising. We have conducted two update days where we discuss new vehicle technologies and techniques introducing specific vehicles to help demonstrate these advancements. This has proved very successful and we will look to continue this action into the future with other makes and models, allowing our instructors to gain this valuable knowledge. Our push into the corporate sector with training in mind has been proving quite encouraging with 11 courses with 92 participants completed. We have also run 10 proficiency courses with 81 participants as well as first aid, chainsaw and sand driving courses over the last financial year. We have taken the opportunity to utilize various training areas around the state in the

past twelve months including the Ballarat District 4x4 complex at Smythesdale, the Portland Dune Buggy Club area, the Tallarook training facility, the Wombat State forest as well as the Werribee training centre. We are still looking to acquire out own dedicated training facility through DELWP and PV and this question is constantly being addressed with the Advisory Committee members and their peers.

This year has seen more club anniversaries being reached, recently one of our founding clubs celebrated their 50th anniversary whilst there has been many 30 and 20 year celebrations also. We would hate to miss the chance to recognize these important achievements so please inform the office of any upcoming dates your club may be looking forward to.

Social media has become a focal point these days for all types of news and information dissemination, we are actively trying to keep up with this challenging and changing landscape thanks to Myles Brown, our younger member in the office who has been an excellent addition to our team taking on the role of projects & events officer.

Our presence at the various 4X4 shows around the state has increased with a more diverse attack being planned for this coming year. The regional shows are looking more attractive as these offer the chance for clubs in those areas to push their membership by highlighting their specific activities and attractions. This proved successful during the year for the clubs who took advantage of the opportunity, please take the chance to use these to your club's advantage in the future. The Tread Lightly message we promote along with our code of conduct is being very well received by both our land manager partners in DELWP and PV with more requests coming for our assistance in the educational aspect whereby they are looking to us to broaden our scope of activities across a much broader area, particularly in the state forest camp ground regions of East Gippsland. It is encouraging to notice the request for communication in this area has increased incredibly since the October regional representatives meeting in Traralgon, where the key topic was compliance issues. Our working relationship with our partners in this area has risen to new heights thanks to the hard work of you all by conducting camp host programs and track clearing work to mention just a couple of things. The acknowledgement of these efforts I can assure you comes from the highest levels in these organisations. We obviously still need to continue to push the educational line and try to shift the attitudes of those who don't yet understand that unless we protect and enhance our landscape we will lose the ability to travel in and around it. We also need to acknowledge our sponsors and advertisers who continue to support us in various ways throughout the year, ensuring that we produce the goods to promote ourselves in the most positive and productive way. A big thank you to Affinity Insurance for their continued support, Volkswagen Australia for the commitment they have given to our aims and purpose and all the advertisers who also assist in keeping our message alive. I am pleased to say that our financial position and direction are sound, and we need to ensure our working relationships with the government and their agencies are maintained and continue to strengthen this into the future.

Finally, I would like to thank the team who I have the privilege to work with in the office, Alison McLaughlin, Karl Norman, Myles Brown and Dave Roberts for their excellent work and support throughout the year.

TREASURER'S REPORT 2016 - 2017



I am pleased to present the Annual Financial Statements for the Victorian Association of Four Wheel Drive Clubs Inc. for the financial year ended 30 June 2017.

The Financial Statements have been prepared by Lindsay Broadway (BGO Accounting & Business Solutions) and audited by Craig Pound of Craig R Pound & Associates. The audit report is unqualified.

The 2017 financial year has been another success for the Association. The trading result for the 2017 financial year was a surplus of \$125,652 (2016: \$121,087 surplus). This result has continued the Associations positive net asset position in 2017 to \$317,598 (2016: \$191,947). In order to remain a viable Association, we must ensure we are in a financially sustainable position well into the future. That said, there will be other costs in the new financial year that are necessary to maintain our RTO standards. The forecast surplus for 2017-2018 is around \$18,000.

Some time has elapsed since the Association had an active Finance Committee. Therefore, I took the necessary steps to reconvene that committee with expertise to examine in detail all of the financial aspects. The Finance Committee first met in May 2017 under new Terms of Reference with members, Gary Doyle, Michael Martin, Garry Lyons, Ken Robinson and myself and I sincerely thank those members for the hours of deliberating over financial reports, budgets and anything else that could potentially affect Four Wheel Drive Victoria (FWDV).

The Association has three pillars of revenue, being membership fees, our RTO (Registered Training Organisation) and Government funding in exchange for very specific key performance indicators (KPI).

The Government funding for 2017 was again \$250,000 which included provision for a Project Officer to assist in the delivery of agreed programs. The Government Funding was received in June 2017, enabling the Association to draw on these funds from 1st July, which is of great benefit to our cash flow. The Association continues to provide highly valued services to the Land Managers, working to ensure that funding continues into the future.

Training revenues were up 55% from 2016, as a direct result of the work of FWDV CEO Wayne Hevey. The Board has looked at this as an unusual increase with no guarantee of it continuing at that rate. Therefore, the 2017-2018 budget shows a "cautious" increase. Our RTO status ensures that the Association provide certified training courses to clubs and commercial organisations. A focus on this area will allow training revenues to continue over the next 12 months.

Membership fees dropped slightly from the 2016 result (about 3%) but the Board is not concerned about that at this stage. Our 2017 budget includes funds to further promote the Association both within the Melbourne metropolitan area and in the regional areas to actively work towards attaining higher levels of membership. The member fee that the Association receives from clubs was not increased for 2017-2018.

Whilst it has taken a little time for me personally to "come to grips" with the Association's finances, I am thoroughly enjoying my role as a Board Member. That would not be the case if I didn't have the wonderful support from Karl Norman our Book-keeper, all of the office staff and every member of the Board. My sincere thanks for that and I look forward to another year as your Treasurer.

Notes of the Financial Statements

Four Wheel Drive Victoria ABN 40 891 301 368 For the year ended 30 June 2017

Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act Victoria. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

Income Tax

The income tax expense (income) for the year comprises current income tax expense (income) and deferred income tax expense (income).

Current income tax expense charged to profit or loss is the tax payable on taxable income. Current tax liabilities (assets) are measured at the amounts expected to be paid to (recovered from) the relevant taxation authority.

Deferred income tax expense reflects movements in deferred tax asset and deferred tax liability balances during the year as well as unused tax losses.

Current and deferred income tax expense (income) is charged or credited directly to equity instead of profit or loss when the tax relates to items that are credited or charged directly to equity.

Except for business combinations, no deferred income tax will be recognised from the initial recognition of an asset or liability where there is no effect on accounting or taxable profit or loss.

Deferred tax assets and liabilities are calculated at the tax rates that are expected to apply to the period when the asset is realised or the liability is settled and their measurement also reflects the manner in which the committee expects to recover or settle the carrying amount of the related asset or liability.

Deferred tax assets relating to temporary differences and unused tax losses are recognised only to the extent that it is probable that future taxable profit will be available against which the benefits of the deferred tax asset can be used.

Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

Impairment of Assets

At the end of each reporting period, the committee reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in the income and expenditure statement.



Employee Provisions

Provision is made for the association's liability for employee benefits arising from services renderedby employees to the end of the reporting period. Employee provisions have been measured at theamounts expected to be paid when the liability is settled.

Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

Cash and Cash Equivalents

Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.



Leases

Leases of PPE, where substantially all the risks and benefits incidental to the ownership of the asset (but not the legal ownership) are transferred to the association, are classified as finance leases.

Finance leases are capitalised by recording an asset and a liability at the lower of the amounts equal to the fair value of the leased property or the present value of the minimum lease payments, including any guaranteed residual values. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for that period.

Leased assets are depreciated on a straight-line basis over the shorter of their estimated useful lives or the lease term. Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are charged as expenses in the periods in which they are incurred.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in theassets and liabilities statement.

Financial Assets

Investments in financial assets are initially recognised at cost, which includes transaction costs, and are subsequently measured at fair value, which is equivalent to their market bid price at the end of the reporting period. Movements in fair value are recognised through an equity reserve.

Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

AUDITORS' REPORT TO THE MEMBERS OF

Scope
